During the visit, the following queries were raised:

Query 1

As the power station will be turned off for refurbishment, what will be the source of power for the works?

Reply 1

The successful tenderer will need to apply to the Central Electricity Board for a power connection from the nearby available power source.

Query 2

What is the approximate capacity of the winch?

Reply 2

The winch has been used by the CEB to lift a safe load of not more than 3 Tonnes.

At the request of bidders present, it was agreed to have a second site visit as follows:

- A second site visit will be held on Thursday 25 October 2018 from 09 00 to 14 00 to allow bidders to take measurements and familiarize with the scope of works. Access within the power station will be limited from 10 00 to 12 00.
- 2. Bidders to submit to the CEB the list of personnel who will attend the site visit and the number plates of vehicles for access control by Wednesday 24 October 2018. All visitors to wear full PPE and take all safety precautions on site.
- 3. No Questions/ Answers session shall be held on that day.
