#### **Qualifications and Experience**

##### **1. Trainee Technician II**

(i) Candidates should have completed at least Form III

**AND**

(ii) Brevet D'Aptitude Professionnelle in an Electrical/Electrotechnics field or Fabrication Mecanique

**OR**

(iii) City & Guilds in Electrical and Electronic Engineering Technician or Mechanical Engineering Level 2

**OR**

(iv) NTC 2 in Industrial Machine Maintenance or Industrial Electronics

**OR**

(v) NTC 3 in Maintenance Fitting or Welding & Metal Fabrication

**OR**

(vi) Any other relevant technical qualifications acceptable to the Board.

##### **2. Cadet Technician**

(i) Candidates should possess qualifications mentioned at 1 above

**AND**

(ii) A minimum of 2 years' experience in a recognized firm in the relevant field.

#### **Age Limit**

Applicants should not have reached their 48<sup>th</sup> birthday by the closing date.
